For general Insecticides, Herbicides, Fungicides		
High Volume Power Spray	100mL per 100L	Always consult the pesticide label for exact application rates.
Low Volume Boom Spray	40mL per 100L	
Misting Machine	5mL per 5L	
Knapsack	2mL per 15L	
For Contact Herbicides e.g. Paraquat		Spray until stems and leaves are wet. These higher rates ensure the plants are thoroughly wetted.
High Volume Power Spray and Boom Spray	120mL per 100L	
Knapsack	20mL per 15L	
For Selective Herbicides e.g. "dims and tops"	200-250mL per 100L	Using COUNTRY Wetter 1000 outside pesticide label directions may reduce selectivity. DO NOT add COUNTRY Wetter 1000 when mixing diclofop with a broadleaf herbicide.
Soil Residual Herbicides e.g. diuron	100-400mL per 100L	See pesticide label for exact rates.

GENERAL INSTRUCTIONS

COUNTRY Wetter 1000

- Is a spray additive suitable for herbicides.
- Increases wetting and spray coverage.
- Is suitable for use with all types of water.
- Is suitable for high and low volume spraying.
- Is 100% active non-ionic surfactant.
- Can be used with acid and alkaline sprays.

PREPARATION

Fill tank to at least half with water. Add Country Wetter 1000 and stir. Add pesticide and stir. Top up tank with required amount of water. Stir until completely mixed. DO NOT add directly to undiluted sprays containing wetting agents.

Only use wetter where directed on the pesticide label. Refer to the label of the pesticide to be mixed with for further instructions. See **First Aid** and **Safety Directions**.

PROTECTION OF WILDLIFE, FISH, CRUSTACEANS AND ENVIRONMENT

Toxic to fish. DO NOT contaminate streams, rivers and waterways with the chemical or used containers.

STORAGE AND DISPOSAL

KEEP OUT OF REACH OF CHILDREN. Store in the closed, original container in a dry, cool, well ventilated area. DO NOT store for prolonged periods in direct sunlight. Triple or preferably pressure rinse containers before disposal. Add rinsings to spray tank. DO NOT dispose of undiluted chemicals on-site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush or puncture and bury empty containers in a local authority landfill. If no landfill is available, bury the containers below 500mm in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots. Empty containers and product should not be burnt.

For refillable containers: Empty contents fully into application equipment. Close all valves and return to point of supply for refill or storage.

Avoid all skin and eye contact. Wear rubber/PVC gloves, goggles and overalls.
