4. FIRST AID MEASURES

4.1 Description of first aid measures

Eye If in eyes, hold eyelids apart and flush continuously with running water. Continue flushing until advised to stop by a Poisons Information Centre, a doctor, or for at least 15 minutes.

Inhalation If inhaled, remove from contaminated area. To protect rescuer, use a Type B (Inorganic and acid gas) respirator where an inhalation risk exists. Apply artificial respiration if not breathing.

Skin If skin or hair contact occurs, remove contaminated clothing and flush skin and hair with running water. Continue flushing with water until advised to stop by a Poisons Information Centre or a doctor.

Ingestion For advice, contact a Poisons Information Centre on 13 11 26 (Australia Wide) or a doctor (at once). Rinse mouth out with water and give plenty of water to drink.

5. FIRE FIGHTING MEASURES

5.1 Extinguishing media

Contain the fire with sand or earth or use carbon dioxide, water fog, dry powder or alcohol foam extinguishers prior to the arrival of the Fire Brigade.

5.2 Special hazards arising from the substance or mixture

Non flammable. May evolve toxic gases (sulphur oxides) when heated to decomposition. May evolve flammable hydrogen gas in contact with some metals. Thermal oxidative decomposition does not occur at temperatures below 600°C.

5.3 Advice for firefighters

Treat as per requirements for surrounding fires. Evacuate area and contact emergency services. Remain upwind and notify those downwind of hazard. Wear full protective equipment including Self Contained Breathing Apparatus (SCBA) when combating fire. Use waterfog to cool intact containers and nearby storage areas.

12.1 Toxicity

Aluminium ammonium sulphate is of low environment toxicity.

12.2 Persistence and degradability

For inorganic metal salts the concept of biodegradation is not applicable in general (OECD, 2001). Removal of aluminum from solution via precipitation and abiotic processes is dominant. Aluminum is abundant in the environment from natural mineral sources.

12.3 Bioaccumulative potential

Bioaccumulation and secondary poisoning are not considered significant. Aluminum is not expected to bioaccumulate in organisms and food chains.
