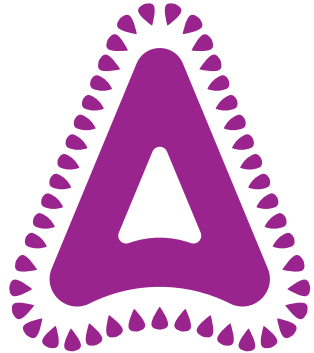

STORAGE, SPILLAGE AND DISPOSAL

Store in the closed, original container in a dry, cool, well-ventilated area, away from children, animals, food and feedstuffs. DO NOT store for prolonged periods in direct sunlight. DO NOT store at temperatures below 5°C. In case of spillage, confine and absorb the spilled product with absorbent material such as sand, clay or cat litter and dispose of waste as indicated below or according to the Australian Standard 2507 – Storage and Handling of Pesticides. DO NOT re-use empty containers. This container can be recycled if it is clean, dry, free of visible residues and has the *drumMUSTER* logo visible. Triple-rinse container for disposal. Dispose of rinsate by adding it to the spray tank. DO NOT dispose of undiluted chemical on site. Wash outside of the container and the cap. Store cleaned container in a sheltered place with cap removed. It will then be acceptable for recycling at any *drumMUSTER* collection or similar container management program site. The cap should not be replaced, but may be taken separately. If not recycling, break, crush, or puncture and deliver empty packaging to an approved waste management facility. If an approved waste management facility is not available, bury the empty packaging 500 mm below the surface in a disposal pit specifically marked and set up for this purpose, clear of waterways, desirable vegetation and tree roots, in compliance with relevant local, state or territory government regulations. DO NOT burn empty containers or product.

SAFETY DIRECTIONS

Poisonous if swallowed. May irritate the eyes and skin. Repeated exposure may cause allergic disorders. Avoid contact with eyes and skin. For hand held application: When opening the container and preparing spray, wear cotton overalls buttoned to the neck and wrist, a washable hat and elbow-length PVC or nitrile gloves. When using the prepared spray wear protective waterproof clothing, elbow length PVC or nitrile gloves and water resistant footwear. After each day's use, wash gloves, contaminated clothing. Wash hands after use.

For termite control in buildings and structures:

When opening the container and preparing spray, wear cotton overalls buttoned to the neck and wrist and a washable hat and elbow-length PVC or nitrile gloves. When using the prepared spray, wear cotton overalls buttoned to the neck and wrist and a washable hat and elbow-length PVC or nitrile gloves. After each day's use wash contaminated clothing and gloves.
