DIRECTIONS FOR USE

SPRAY MARKING: Suitable for use with both liquid and powder products and can be used to help identify sprayed areas.

FOAM MARKER DYE: Where a coloured foam is required for foam markers, add at the recommended rate to the dilute foam mixture.

RATE OF APPLICATION

RATE	VOLUME	CRITICAL COMMENTS
5-10mL	per 10L of spray solution	Use the higher rate if more intense colour marking is required.
50-100mL	per 100L of spray solution	
20-30mL	per 10L of foam marker diluted mixture	Will convert white foam to pink for easier identification in specific situations.

GENERAL INSTRUCTIONS

The concentrate and spray solution of Spray Marker Dye is dye fast on contact with most materials. DO NOT allow spray drift to come into contact with the paint work of motor vehicles. Spray Marker Dye is suitable for use with both liquid and powder formulations and can be used to visually mark sprayed areas.

Suggested uses include:

- Marking trial plots and strips.
- · Marking to help prevent farmers/contractors over-spraying.
- · Line marking of ovals and courts.

When used as a foam marker colouring agent, white foam will become pink in colour to assist identification.

MIXING

Premix Spray Marker Dye with water and add to the spray tank first. Agitate or mix thoroughly in the tank before adding any other product.

Important: When using with amine based products such as Amicide® 625 and MCPA 500, ensure that the Spray Marker Dye is thoroughly mixed with the water before adding the herbicide. Wash out spray equipment thoroughly after use. If product residue is left in equipment colouration of subsequent sprays can be expected.

PROTECTION OF WILDLIFE, FISH, CRUSTACEANS AND ENVIRONMENT

DO NOT contaminate streams, rivers or waterways with the chemical or used containers.

STORAGE AND DISPOSAL

KEEP OUT OF REACH OF CHILDREN. Store in the closed, original container in a cool, well ventilated area. DO NOT store for prolonged periods in direct sunlight. Triple or preferably pressure rinse containers before disposal. Add rinsings to spray tank. DO NOT dispose of undiluted chemicals on-site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush, or puncture and bury empty containers in a local authority landfill. If no landfill is available, bury the containers below 500mm in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots. Empty containers and product should NOT be burnt.

DO NOT swallow. Avoid contact with eyes and skin. DO NOT inhale spray mist. If product on skin, immediately wash area with soap and water.
